
Caring for our Watersheds


Our wonderful volunteer teams see to it that our creeks are cared for and bring passion for encouraging and promoting the enjoyment of the environments in our watersheds.

This last year has seen us not only hire remarkable talent to improve the planning and execution of our vital programs, but we have been the recipients of a record outpour of support indicating how important our core programs are to the health of our watersheds and communities.

Streams Cleanup

CRC has been a force for environmental stewardship in our community for many years, and one of the things we are best known for is the Annual Streams Cleanup. This year we entered our third decade of cleaning the Chester, Ridley and Crum creeks with our 21st consecutive Earth Day cleanup event.

On April 21 over 800 volunteers came out to 34 different sites throughout the area. We are grateful to this enthusiastic group of people, many who come back to the Cleanup year after year. Under the supervision of our dedicated Site Coordinators, they pulled out over ten tons of trash! Our intrepid volunteers do what is necessary to get the work done, from wading through the streams, to towing large items out of the water, to picking up debris along the streambeds. As always, the volunteers find an incredible array of items – this year they pulled out a trampoline, tires, engine block,

and shopping carts. Although it can be disheartening to see these items polluting our streams, it is ultimately gratifying and imperative that the trash be removed. And in some cases, the volunteers report that sites seem

cleaner year after year. Once an area is relatively free of trash, people are less likely to dump items. We are seeing long-term positive results from this yearly event.

We are grateful to the many people and organizations who make the Annual Streams Cleanup possible. The Site Coordinators take on the substantial responsibility and give many hours to managing their site preparations and overseeing their volunteers. Various organizations provide financial support through sponsorships and supply donations. Area municipalities share our goals and values and give their support through coordination and promotion. And hundreds of like-minded people – ranging from young children to senior citizens – get their hands dirty every year to make our watersheds that much cleaner. All of this exceptional work, passion and commitment come together to forward the CRC mission to preserve and protect our environment.





Trees in our Watersheds

We are proud of our past and current tree plantings. Since 2005, CRC, our volunteers, and partners have planted over 8,000 trees and shrubs in riparian and upland areas to slow and reduce stormwater runoff, reduce erosion and sediment load to our streams, filter groundwater, provide habitat, and increase shade to reduce invasives and improve the overall health of our watersheds. We see extensive growth for this program due

to municipal need and community interest. We will be planning and conducting many more large tree and shrub installations in the coming year.

In the past year, CRC conducted plantings in Crozer Park, Chester; Edgmont Little League Field/ Gable Park Newtown Square; Serpentine Preserve, Willistown; and Rose Tree Park, Media.

The needs of our plantings do not end after the trees are in the ground. While CRC has always worked to maintain their plantings, we have started a more concerted effort to identify areas we have planted that need attention to control invasive weeds, overgrowth, and replenish mulch and caging around the trees and shrubs. Some invasive management is included during each planting

event (in fact, some of our volunteers really enjoy pulling vines and yanking Japanese hops off our planting sites). We have worked at Darlington Trail, Middletown and Crozer Park, Chester where we previously planted to continue to maintain the trees and shrubs.

Our Tree Planting Fund, which started at the 12th CRC Annual Awards Dinner, uses donations for planting and maintaining trees and shrubs. We continued the tradition at the 2017 Dinner, and have started a CRC Tree Fund, GoFundMe page (gofundme.com/crc-tree-fund).

and DePuy Synthes.





Education and Outreach

This year the Education and Outreach Committee continued to build its innovative "Yellow Shirts" program, expanding the Yellow Shirts corps to include all the site coordinators for our annual Streams Cleanup. Yellow Shirts are volunteers who act as CRC ambassadors at each of our events. They mingle with volunteers and provide information in informal, one-on-one conversations. They answer questions about our watersheds, explain the challenges facing our streams, and share facts about how CRC is improving the health of our local ecosystem. We now have more than 80 Yellow Shirts. We appreciate the willingness of these key volunteers to do whatever is needed – carry buckets of water, apply band-aids, or tell stories about the important work CRC is doing.

In June of 2018, CRC hosted the first Stream Side Nature Hike. Although the hike was initially limited to 30 people, a few more than 30 showed up on the wet Sat-


urday morning at Ridley Creek State Park where hike leaders Kevin Magerr (EPA Environmental Engineer), Ralph Spagnolo (EPA Wetland Biologist), and Gary Stolz (Ridley

And, along with Yellow Shirt Maggie Dunn, they answered questions about how CRC is helping protect this vital ecosystem. Another Nature Hike is planned for June 2019.
